ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1) (VARIOUS ROADS) (TEMPORARY RESTRICTION OF TRAFFIC)(NO. 4) ORDER 2017

- 1. The London Borough of Merton Council hereby give notice that to facilitate a programme of carriageway resurfacing to be undertaken in London Road, Raleigh Gardens, Upper Green East, the south-west arm, and Upper Green West, the south-west arm, they intend to make an Order, the effect of which would be to temporarily restrict vehicular traffic in the aforementioned roads and in Prince George's Road, SW19 and Tandem Way, SW19.
- 2. During the works, no person would cause or permit any vehicle to:-
 - (a) enter, proceed in, or wait in any of the roads or lengths of roads specified in column 1 of the Schedule to this Notice;
 - (b) turn left into Upper Green West, the south-west arm from Holborn Way:
 - (c) turn right into Upper Green West, the south-west arm from Raleigh Gardens;
 - (d) wait, including for the purpose of loading or unloading (to facilitate a bus diversion), in:-
 - (i) Tandem Way and
 - (ii) Prince George's Road, between its junction with Christchurch Road and its junction with Tandem Way.
- Any designated parking place situated in any of the roads or lengths of roads specified in column 1 of the Schedule to this Notice would be suspended for the duration of the works in those roads or lengths of roads.
- 4. Alternative routes for diverted traffic would be indicated by advance warning and diversion signs on the roads affected when the works are in progress but would likely be those diversion routes specified in column 2 of the Schedule to this Notice.
- 5. The restrictions would apply only during such times and to such extent as would from time to time be indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2016.
- 6. Any vehicle that is in contravention of any waiting restrictions imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.
- 7. Nothing in the Order would apply to: -
 - (a) any vehicle being used in connection with the execution of the said works or any public service or utility vehicle; or
 - (b) anything done with the permission or at the direction of a police officer in uniform or a police community support officer in uniform; or
 - (c) emergency service vehicles, subject to site conditions at the time of any emergency.
- 8. Nothing in sub-paragraphs 2(a) to (c) above would apply to any person requiring vehicular access to properties adjacent to the prohibited roads or length of roads insofar as access is reasonably practicable without interference with the said works.
- 9. The Order would come into operation on Monday 3rd April 2017 and the anticipated works dates are specified in column 3 of the Schedule to this Notice. However, the Order would remain in operation for a maximum period of 6 months and its provisions would be reintroduced during that time should further works be required.
