## ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1) UPPER GREEN EAST AND UPPER GREEN WEST (TEMPORARY RESTRICTION OF TRAFFIC) ORDER 2017

- The London Borough of Merton Council hereby give notice that to facilitate road marking and signage works to be undertaken in Upper Green East (the north-eastern arm) and Upper Green West (the northern arm) they intend to make an Order, the effect of which would be to temporarily restrict vehicular traffic in the above mentioned roads.
- 2. During the works:-
  - (a) no person would cause or permit any vehicle to:-
    - (i) enter into or proceed in any of the roads or lengths of road specified in the Schedule to this Notice;
    - (ii) wait, including for the purpose of loading or unloading in any of the roads or lengths of road specified in the Schedule to this Notice;
  - (b) the one way workings in the roads or lengths of road specified in Schedule to this Notice would be suspended.
- Any designated parking place situated in any of the roads or lengths of roads specified in column 1 of the Schedule to this Notice would be suspended for the duration of the works in those roads or lengths of roads.
- 4. A diversion route would not be necessary during the works.
- 5. The restrictions would apply only during such times and to such extent as would from time to time be indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2016.
- 6. Any vehicle that is in contravention of any waiting restrictions imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.
- 7. Nothing in the Order would apply to: -
  - (a) any vehicle being used in connection with the execution of the said works or any public service or utility vehicle; or
  - (b) anything done with the permission or at the direction of a police officer in uniform or police community support officer in uniform; or
  - (c) emergency service vehicles, subject to site conditions at the time of any emergency.
- 8. Nothing in sub-paragraph 2(a)(i) above would apply to any person requiring vehicular access to properties adjacent to the prohibited roads or lengths of roads insofar as access is reasonably practicable without interference with the said works.
- 9. The Order would come into operation at 9pm on Monday 27th November 2017 and works are anticipated to be completed by 6am the following day. However, the Order would remain in operation for a maximum period of 6 months and its provisions would be re-introduced during that time should further works be required.
