"Class A. The erection, construction, maintenance, improvement or alteration of a gate, fence, wall or other means of enclosure"

where they abut a highway used by vehicular traffic or within 7 metres of a highway used by vehicular traffic.

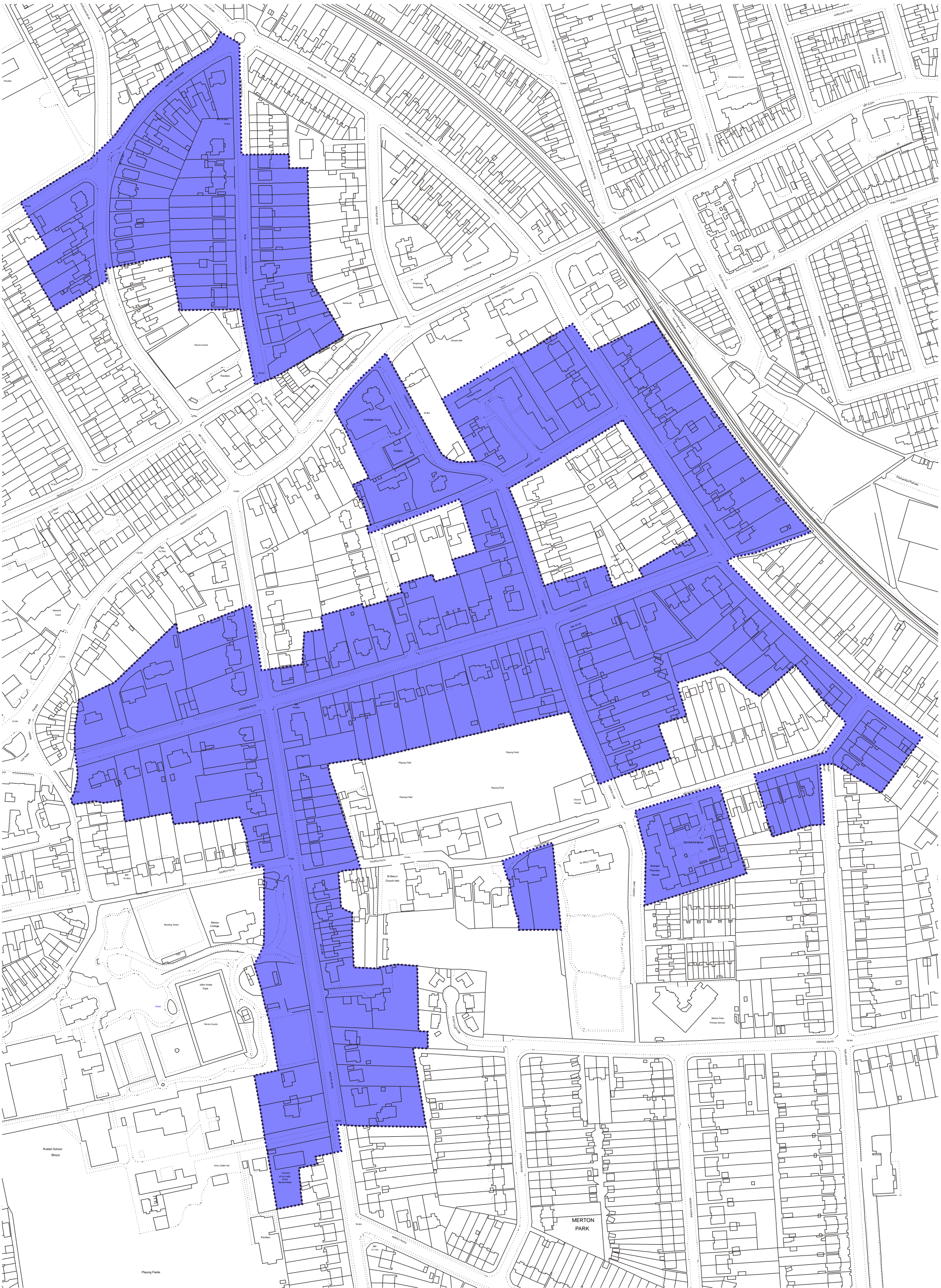

Map of Properties Affected

The Article 4 Direction requires planning permission to be sought for certain kinds of work, which normally would not require a planning application to be made.

The following works to property affected by the Direction will require a planning application to be made, regardless of their size, or proximity to neighbouring properties.

The erection, construction, maintenance, improvement or other alteration of gates, fences, walls or other means of enclosure, where they abut a highway used by vehicular traffic or within 7 metres of a highway used by vehicular traffic. This would include the removal of hedges.
