

Please be reminded that if a CPZ is to be implemented in the roads as shown on the plan, parking is likely to be displaced into the roads/part of roads not within the CPZ. This displacement is likely to be caused by commuters and those residents in the proposed CPZ who may not want to pay for a permit. In order to have your road/(s) re-considered for a CPZ, the Council would require a petition or/and written representations.

The result of the consultation along with officers' recommendations will be presented in a report to Street Management Advisory Committee and/or the Cabinet Member for Environmental Sustainability and Regeneration. Once a decision is made you will be informed accordingly. Please note that responses to any representations received will not be made until a final decision is made. ## Controlled Parking Zone (CPZ) CW CPZ Review and Extension

Dear Resident / Business,

The purpose of this leaflet is to let you know the outcome of the informal consultation carried out in September/October 2010 on proposals to improve the operation of the existing "CW" Controlled Parking Zone (CPZ) and the proposed extension to include parking controls in the Fortescue Road area.

### EXISTING CPZ (ZONE CW)

The consultation resulted in a total of 189 questionnaires returned, representing a response rate of 10.6%. As it can be seen from the enclosed tables, a majority of 81.9% of respondents do not want the days of operation to be increased to include Saturday; 46.6% want the operating hours changed compared to 45.5% who do not.

Over the past few years the Council has received many complaints from residents who live on the west side of Colliers Wood CPZ requesting that the operational days of the zone be increased to include Saturdays, whilst residents who live on the eastern side want the hours of operation to be reduced. As a result of these requests further analysis was carried out and the zone was split into east and west of the High Street. ### CW CPZ EXTENSION

A consultation was also carried out in those roads that are not within a CPZ. The consultation resulted in a total of 152 questionnaires returned, representing a response rate of 31.3%. A majority of 56.6% of respondents indicated that they currently have parking problems in their roads compared to 40.1% who feel that they do not. A majority of 48.7% support the concept of a CPZ, compared to 42% who do not.

For further details please refer to the enclosed consultation results.

In view of the feedback received, it has been decided to exclude those roads (Colwood Gardens, Courtney Road, Christchurch Close and Alpeha Close) which did not support a CPZ nor would they if introduced in neighbouring road/s. Those roads that are being excluded from the proposed CPZ will still be subject to waiting restrictions at key locations such as junctions, bends and cul-de-sacs to ensure safety and access at all times. These proposed measures are subject to a separate statutory consultation, which will provide a further opportunity for residents to air their views and raise any objections.

#### Cabinet Member's Decision

The results of the informal consultation along with your views and officers' recommendations were presented in a report to the Street Management Advisory Committee and the Cabinet Member on the 10 February 2011. After careful consideration, the following were agreed:

#### EXISTING CW CPZ

**A)** To proceed with a statutory consultation and the publication of the relevant draft Traffic Management Orders (TMOs) on the Council's intention to introduce the following proposed amendments to the existing 'CW' CPZ, as shown on drawing no. Z78/181/01 enclosed.

1. Convert the existing single permit holder bay to a 'Car Club' bay adjacent to the flank wall of property no. 80 High Street Colliers Wood.
2. To introduce a Solo Motorcycle bay in College Road adjacent to the flank wall of property no. 80 High Street Colliers Wood.
3. To introduce an additional pay and display shared use bay in Acre Road outside property no. 3, with a maximum stay of two hours.
4. To introduce double yellow lines restrictions at all key locations to ensure access and improved sightlines.
5. NOT to proceed with the proposed optional changes to the existing 'CW CPZ, based on the majority view expressed by residents and businesses who responded to the consultation.

#### CW CPZ EXTENSION

**B)** To proceed with a statutory consultation and the publication of the relevant draft Traffic Management Orders (TMOs) on the Council's intention to extend the boundary of the existing CW CPZ to include the following roads: Fortescue Road, Clarendon Road and Christchurch Road (even numbers only between Nos. 40 and 74 Christchurch Road) to obtain parking permits for 'CW' CPZ. The zone will be operational, Mondays to Friday between 8.30am and 6.30pm, and include the following.

1. To introduce pay and display only parking bays on both side of Fortescue Road near its junction with Christchurch Road, with a maximum stay of two hours only.
2. To introduce a Car club bay in Fortescue Road near its junction with Christchurch Road.
3. To introduce pay and display shared-use parking bays on the north side of Fortescue Road outside Oasis Church, with a maximum stay of two hours only.
4. To introduce double yellow lines restrictions at all key locations to ensure access and improved sightlines.

Additionally it was also agreed that:

- In the event of a decision being made to proceed with the introduction of a CPZ as described in (B) above, Colwood Gardens, Courtney Road, Christchurch Close and Alpeha Close will be considered as part of the extension during a review.
- To move to statutory consultation for the inclusion of Colwood Gardens, Courtney Road, Christchurch Close and Alpeha Close in the CPZ if parking conditions in those roads deteriorate.

#### WHAT HAPPENS NEXT

A Notice of the Council's intentions to introduce the above measures will be published in a local newspaper, London Gazette and posted on lamp columns in the vicinity. Representations for and against the proposals described in this Notice must be made in writing to the **Head of Street Scene and Waste, Merton Civic Centre, London Road, Morden, Surrey, SM4 5DX** or email [trafficandhighways@merton.gov.uk](mailto:trafficandhighways@merton.gov.uk) by no later than **10 June 2011**, quoting reference **ES/SGE/ZONE CW**. Objections must relate only to the elements of the scheme that are subject to this statutory consultation.

All representations along with Officers' comments and recommendations will be reported to the Cabinet Member for Environmental Sustainability and Regeneration for a decision. Please note that responses to any representations received will not be made until a final decision is made by the Cabinet Member.

The Council is required to give weight to the nature and content of your representations and not necessarily the quantity. Your reasons are, therefore, important to us.
