The Council of the London Borough of Merton (hereinafter referred to as "the council") having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 32, 35 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a), as amended by section 8 of, and Part 1 of Schedule 5 to the Local Government Act 1985(b), and all other powers thereunto enabling hereby make the following Order:

1. Commencement and Citation

This Order may be cited as The Merton (Off-Street Parking Places) (No. *) Order 202* and shall come into force on * 202*.

2. Interpretation

- (1) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them: -
 - (a) "Article" means an article of this Order;
 - (b) "authorised vehicle" means a vehicle making deliveries of goods to, or collections of goods from, the Morden Leisure Centre;
 - (c) "charging hours" in relation to a parking place means the period specified as such in Column 2 of any item in the Schedule;
 - (d) "charging post", means a device designed for the charging of electric vehicles;

- (e) "civil enforcement officer" has the same meaning as in the Traffic Management Act 2004(c); "Council" means the Council of the London Borough of Merton;
- (f) "diesel vehicle" means a vehicle in which the motive power is wholly or partially derived directly or indirectly from a compression ignition engine;
- (g) "disabled person" and "disabled person's badge" have the same meanings as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000(d);
- (h) "driver", in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place;
- "electric vehicle" means any vehicle means any vehicle, which is propelled entirely or partially by electricity and is capable of being charged from an external source;
- (j) "electronic payment system" means an electronic system, using an electronic application set up and maintained by the service provider whereby:
 - (i) the driver of a vehicle, or some other person authorised by that driver on their behalf, uses a electronic apparatus to communicate with the service provider and make payment of the charge for a permit in respect of a specified vehicle, specified parking places and for a specified period by use of a debit or credit card or an electronic means of payment, in accordance with instructions given by the service provider at the time of using the system; and
 - (ii) the service provider, on behalf of the Council, accepts payment of the charge for a permit by the method referred to in paragraph (i) of this definition and records such payment together with the details of the permit or season ticket for which payment has been made and the registration mark of the vehicle in respect of which payment has been made:"
- (k) "Euro 4 compliant vehicle" means a petrol vehicle in respect of which there is issued a valid UK registration document or foreign registration document on which the vehicle's exhaust emissions specified are those below the limits set for compliance with the Euro 4 emissions standard set out in the rows corresponding with Category B in the first of the tables at section 5.3.1.4 of Annex I to Council Directive 70/220/EEC on type approval of motor vehicles which respect to emissions from light passenger vehicles and on access to vehicle repair and maintenance information or a petrol vehicle for which the Council has obtained information from the Vehicle Certification Agency which shows the vehicle meets the Euro 4 emissions standard;

- (I) "Euro 6 compliant vehicle" means a diesel vehicle in respect of which there is issued a valid UK registration document or foreign registration document on which the vehicle's exhaust emissions specified are those below the limits set for compliance with the Euro 6 emissions standard set by Regulation (EC) No. 715/2007 of the European Parliament and of the Council of 20 June 2007 on type approval of motor vehicles with respect to emissions from light passenger and commercial vehicles (Euro 5 and Euro 6) and on access to vehicle repair and maintenance information or a diesel vehicle for which the Council has obtained information from the Vehicle Certification Agency which shows the vehicle meets the Euro 6 emissions standard;
- (m) "fuel cell vehicle" means a vehicle in which the electrical motive power is derived from hydrogen and which is not connected to any source of power derived from fossil fuel when the vehicle is in motion;
- (n) "fully electric vehicle" means any vehicle means any vehicle, which is propelled entirely by electricity and is capable of being charged from an external source;
- (o) "goods vehicle" means a motor vehicle constructed or adapted for use for the carriage of goods or burden of any description, or a trailer so constructed or adapted;
- (p) "hand-held device" means a wireless hand-held computer used by a parking attendant, which is programmed to interface with the telephone payment parking system;
- (q) "light commercial vehicle" means a vehicle type approved as a category N1, class I, II or III vehicle (vehicles designed and constructed for the carriage of goods and having a maximum mass not exceeding 3.5 tonnes) within the meaning of Annex II of Council Directive 2007/46/EC;
- (r) "light passenger vehicle" means a vehicle type approved as a category M1 vehicle (vehicle with at least four wheels used for carriage of passengers and comprising no more than 8 seats in addition to the driver's seat) within the meaning of Annex II of Council Directive 2007/46/EC:
- (s) "loading area" means any part of a parking place marked out by means of white lines or otherwise, for the leaving of vehicles and goods vehicles for the purpose of continual loading or unloading;
- (t) "local worker" means an employee of a business or at business premises the postal address of which is in a street or part of a street in the London Borough of Merton;
- (u) "motor car" means a mechanically propelled vehicle not being a motor cycle or an invalid carriage or a commercial vehicle the weight of which un-laden exceeds 1525kg, which is constructed to carry a load or passengers;

- (v) "motor cycle and invalid carriage" have the same meaning respectively as in section 136 of the Road Traffic Regulation Act 1984;
- (w) "owner", has the same meaning as in the Civil Enforcement of Parking Contraventions (England) General Regulations 2007(e);
- (x) "parking area" means any part of a parking place marked out by means of white lines or otherwise, for the leaving of motor cycles;
- (y) "parking charge" means an amount specified in Column 5 of the Schedule to this Order which is payable, subject to the provisions of this Order, at a ticket machine or by using the telephone payment parking system in respect of a vehicle left in a parking place referred to in the Schedule;
- (z) "parking contravention" has the meaning as assigned to it in Part 1 of Schedule 7 of the Traffic Management Act 2004;
- (aa) "parking place" means any area of land specified by name in Column 1 of the Schedule provided by the Council and approved for such purpose under section 32(1) or 33(7) of the Road Traffic Regulation Act 1984;
- (bb) "parking space" means any part of a parking place marked out by means of white lines or otherwise for the leaving of a vehicle other than a motor cycle;
- (cc) "penalty charge" has the same meaning as in the Civil Enforcement of Parking Contraventions (England) General Regulations 2007;
- (dd) "penalty charge and reduced penalty charge" means a charge set by the Council under the provisions of Part 6 of the Traffic Management 2004 and with the approval of the Secretary of State for Transport which is to be paid to the Council within 28 days beginning on the date of the Notice, or in 14 days in the case of a reduced penalty charge, following the issue of the penalty charge notice;
- (ee) "penalty charge notice" has the same meaning as in the Civil Enforcement of Parking Contraventions (England) General Regulations 2007;
- (ff) "permit" means a parking device issued under the provisions of Article 9(2) of this Order;
- (gg) "petrol vehicle means a vehicle in which the motive power is wholly or partially derived directly or indirectly from an internal combustion engine with spark-ignition designed to run on petrol and includes hybrid vehicles which use petrol as a fuel source;
- (hh) "public service vehicle" means the same as the Public Service Vehicle Act 1981(f);

- (ii) "registration date", in relation to a vehicle, means the date of first registration of that vehicle as specified on the UK registration certificate issued in respect of that vehicle;
- (jj) "registered driver" means the driver of a vehicle who has, prior to leaving his or her vehicle in a parking place, registered so many of his or her personal details with a service provider as that service provider may require to enable the telephone payment parking system to be activated in favour of the said driver;
- (kk) "resident" means a person whose usual place of abode is at premises the postal address of which is in any street or part of a street in the London Borough of Merton;
- (II) "restricted area" means any area marked by yellow lines;
- (mm) "Schedule" means a Schedule to this Order;
- (nn) "season ticket" means a parking device issued under the provisions of Article 9(1) of this Order;
- (oo) "service charge" means the charge payable to the service provider (in addition to the parking charge) by persons using the telephone payment parking system;
- (pp) "service provider" means the company authorised and appointed by the Council to operate, administer and maintain the payment of parking charges and charges for any permit or season ticket issued under this Order, using the telephone payment parking system or the electronic payment parking system;
- (qq) "telephone payment parking system" means a system to facilitate and monitor the payment of parking charges using mobile telephone communication with the service provider in accordance with instructions indicated on signs located at each parking place where the system is operational;
- (rr) "ticket" means a ticket issued by a ticket machine relating to a parking place;
- (ss) "ticket machine" means apparatus designed to issue tickets indicating the payment of the charge and the date and time at which the period for which payment was made will expire;
- (tt) "vehicle" includes a motor car, motorcycle, and invalid carriage but does not include a trailer, caravan, stall or other mobile structure;
- (uu) "UK registration certificate" means a current registration document issued to a vehicle in the United Kingdom under the provisions of Regulation 10(4) and 10A of the Road Vehicles (Registration and Licensing) Regulations 2002

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent amendment.
- (3) For the purposes of this Order a vehicle shall be regarded as displaying a disabled person's badge in the relevant position when it is so regarded for the purposes of Regulation 3 of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 2000(g).
- (4) For the purposed of this Order a permit or a season ticket can be considered displayed if records of payment for the said permit or season ticket obtained from the electronic payment system for which the charge has been paid using the electronic payment system show it has been paid for.

3. Revocation

Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the following Order is hereby revoked:

The Merton (Off-Street Parking Places) (No. 1) Order 2019(h).

4. Use of land and parking places

- (1) Each area of land specified by name in Column 1 of the Schedule may be used, subject to the following provisions of this Order, as a parking place for such classes of vehicles, on such days and at such times as are specified in relation to that area in the said Schedule.
- (2) Where in Column 3 of the Schedule a parking place is described as available for vehicles of a specified class, the driver of a vehicle shall not permit it to wait in that parking place unless it is of the specified class.
- (3) A driver leaving a vehicle in a parking place shall not leave the vehicle in a restricted area within the parking place or in any position in the parking place in which it will obstruct access to the parking place, to any premises adjoining the parking place or to any access way within the parking place.
- (4) Every vehicle left in a parking place shall stand so that every part of the vehicle is wholly within the limits of any parking space if so marked.
- (5) (A) The driver of a vehicle shall not permit it to wait in a parking space that has been reserved by means of a sign or surface marking specifically for use by electric vehicles unless:
 - (i) that vehicle is an electric vehicle; and
 - (ii) as soon as it is reasonably possible to do so, that electric vehicle is connected to the electric charging post provided at that parking space for the purpose of the charging that vehicle's battery until immediately prior to it being taken away from that parking space.

- (B) At all times during which an electric vehicle is left at a parking space that has been reserved by means of a sign or surface marking specifically for the use by electric vehicles, the driver thereof shall cause that vehicle to be connected to a charging post relating to that parking space, via the charging lead attached to the charging post, and be actively charged.
- (C) An electric vehicle shall not be left in a parking space that has been reserved by means of a sign or surface marking specifically for the use by electric vehicles for a continuous period:-
 - (i) after the charging post indicates the battery of the electric vehicle is no longer being charged;
 - (ii) exceeding the maximum period of stay indicated on any sign adjacent that parking space.
- (6) Where there is a sign or notice in a parking area or parking space indicating that the use of that parking area or parking space is suspended, the driver of a vehicle shall not permit that vehicle to be left in that parking area or parking space.
- (7) Where, within a parking place, there is a sign or surface marking which indicates that a parking space or parking area or loading area is available only for a particular type or class of vehicle, or for use by a permit holder, no driver shall leave a vehicle in any such parking space or parking area other than of the type, class or for the use so specified.
- (8) A driver leaving a vehicle in a parking place shall not leave the vehicle for longer than the maximum period specified in Column 4 of the Schedule. This restriction shall only apply where the period specified in Column 4 is less than the duration of the charging hours specified in Column 2 of the Schedule.
- (9) A driver who has left a vehicle in a parking place for the maximum period for which vehicles may be left as specified in the last paragraph shall immediately remove the vehicle from the parking place and shall not permit the vehicle to return to the parking place until the expiration of two hours from the time that vehicle was taken away from that parking place.
- (10) Subject to the provisions of this Order, a driver leaving a vehicle in a parking place referred to in the Schedule during the charging hours: -
 - (a) shall cause to be displayed at all times a valid ticket; or
 - (b) shall cause to be displayed at all times a valid permit; or
 - (c) shall cause to be displayed at all times a valid season ticket; or
 - (d) shall use the telephone parking system so that an indication that payment has been made and the parking period for which payment has been made appears on a hand-held device.

5. Display of permits and tickets

(1) At all times during which a vehicle is left in a parking place during the permitted hours and where required to do so by Article 4(10), the driver shall cause either

a valid ticket or a valid permit or a valid season ticket issued for that vehicle, to be displayed in a conspicuous position on the vehicle on or adjacent to the inside of the front or front-side window of the vehicle, so that either:

- (a) all the details on the side of the ticket which bears the date and time are clearly visible from outside the vehicle; or
- (b) all of the details on the side of the permit which bears the permit number are clearly visible from outside the vehicle;

unless an indication that the applicable parking charge and service charge has been paid as may be ascertained by a record that exists in the telephone payment parking system confirming that the parking charge and service charge has been paid with respect to the vehicle; or

unless an indication that the applicable charge for a valid permit or season ticket has been paid as may be ascertained by telephone or on submitting the registration mark of the vehicle with a hand-held device and a response is received via the hand-held device that a record exists in the electronic payments system confirming that the charge has been paid with respect to a valid permit or season ticket for the vehicle

- (2) An issued ticket shall only be valid for the parking place at which it was issued and for the vehicle in respect of which it was purchased and shall neither be transferable to another vehicle nor to another parking place.
- (3) No person shall display on a vehicle left in a parking place referred to the Schedule during the permitted hours any ticket other than the ticket issued by the ticket machine relating to that parking place upon payment of the parking charge in respect of that vehicle.
- (4) No person shall after obtaining a parking ticket alter the indication given by that parking ticket whilst the vehicle to which the ticket relates remains in the parking place, or knowingly exhibit on a vehicle a parking ticket which has been altered, defaced, mutilated or added to or upon which the figures or particulars have become illegible except where such mutilation or illegibility has been produced by the ticket machine.

6. Parking charges

- (1) The parking charges for a vehicle left in a parking place specified in the Schedule during the charging hours shall, subject to Article 6(2) and Article 8, be those specified, in relation to a parking place, in Column 5 of the Schedule to this Order.
- (2) A service charge of a £0.20 shall apply where payment is being made using the telephone payment parking system.

7. Payment of parking charge

(1) A person leaving a vehicle in a parking place referred to in the Schedule can obtain a valid ticket by either;

- (a) the insertion in a ticket machine of any combination of coins together making up the amount of the parking charge for the parking period for which payment is being made and, where more than one coin is required for payment of the parking charge, the coins shall be inserted in the ticket machine one immediately after the other. (Note: ticket machines accept correct payment only - no change is given on over payment of parking charge); or
- (b) use of the telephone payment parking system to pay the parking charge imposed by this Order for the parking period for which payment is being made, by using a telephone or electronic apparatus to communicate with the service provider at the time the vehicle is left in the parking place, in accordance with instructions indicated on signs located at the parking place.
- (2) In the event of the only ticket machine or all ticket machines in a parking place being out of order at the time of the driver's arrival at the parking place payment of the parking charge shall be made using the telephone parking system.

8. Exemption from the parking charge

- (1) The following vehicles left in a parking place shall be exempt from the payment of any parking charge specified in the Schedule provided that they are parked in a parking space or parking spaces expressly reserved for such vehicles by a sign or notice displayed at or adjacent to the said parking space or parking spaces:-
 - (a) an invalid carriage;
 - (b) a vehicle displaying in the relevant position a valid disabled person's badge;
 - (c) a pedal cycle;
 - (d) a motor-cycle;
 - (e) a vehicle being loaded or unloaded in the marked loading area at the Haydon's Road car park;
 - (f) an authorised vehicle being loaded or unloaded in the marked loading area of the Morden Park Car Park Extension;
 - (g) an electric vehicle being actively charged via the charging lead attached to the charging post relating the parking space or parking spaces.
- (2) Nothing in paragraph (1) shall prohibit an invalid carriage or a vehicle displaying in the relevant position a valid disabled person's badge from being left in any other parking space in the parking place.
- (3) Any vehicle waiting in a parking place in York Close Car Park:-
 - (a) between 4.30pm and midnight Monday to Friday inclusive, and between midnight and 8.30am Tuesday to Friday inclusive and all day Saturday whilst displaying a resident's permit issued in respect of Controlled Parking Zone M1, where the permit has been issued to a resident of either York Close or Morden Court shall be exempt from paying the parking charge;
 - (b) in parking spaces marked 237-243 and 245-246 inclusive whilst displaying a BW1 permit shall be exempt from paying a parking charge.

9. Season tickets and permits

- (1) The owner of a vehicle may make application to the Council for a season ticket for a charge specified in in paragraph 7 of this Article and that season ticket shall be valid in such parking place as is specified thereon and during the period for which it is issued.
- (2) The Council may issue permits allowing vehicles to be left in a parking place free of charge and/or free from the maximum period for which vehicles may wait as specified in column 4 of the Schedule and such a permit shall be valid at such parking places as are specified thereon and during the period for which it is issued.
- (3) A season ticket or permit issued in accordance with paragraph (1) or (2) of this Article shall be displayed on the vehicle in accordance with and in the manner specified in Article 5(1) and, as long as such ticket or permit is so displayed and remains valid, no further charge shall be payable by the driver of the vehicle so long as the vehicle is left in the parking place for which the season ticket or permit was issued.
- (4) No person shall after obtaining a season ticket or permit alter the indication given by that ticket or permit whilst the vehicle to which it relates remains in the parking place, or knowingly exhibit on a vehicle a season ticket or permit which has been altered, defaced, mutilated, copied or added to.
- (5) A season ticket or permit shall only be valid for the parking place for which it was issued and for the vehicle or by the user in respect of which or by whom it was obtained or purchased, and shall neither be transferable to another vehicle or user nor to another parking place.
- (6) The issue and availability of season tickets and permits shall be at the discretion of the Council and on such terms as the Council may from time to time determine.
- (7) (A) The charges for a season ticket issued for use by a resident or local worker in
 - (i) the Elm Nursery parking place; or
 - (ii) the Raleigh Gardens parking place; or
 - (iii) the Sibthorp Road parking place;

- (a) subject to paragraphs (b) and (c) below, in respect of any motor car:-
 - £300 in respect of a season ticket which shall be valid for a period of 12 months running from the date on which the season ticket first becomes valid; or
 - (ii) £225 in respect of a season ticket which shall be valid for a period of 6 months running from the date on which the season ticket first becomes valid: or

- (iii) £62.50 in respect a season ticket which shall be valid for a period of 1 month from the date on which the season ticket first becomes valid:
- (b) in respect of any motor car which is neither a Euro 4 compliant vehicle nor a Euro 6 compliant vehicle, the charge specified in subparagraph (a) above shall be increased by:-
 - (i) £150 for a season ticket valid for a period of 12 months running from the date on which the season ticket first becomes valid;
 - (ii) £75 for a season ticket valid for a period of 6 months running from the date on which the season ticket first becomes valid;
 - (iii) £12.50 for a season ticket valid for a period of 1 month running from the date on which the season ticket first becomes valid;
- (c) in respect of any motor car which is also a fully electric vehicle the charge shall be £20 for a season ticket valid for a period of 12 months running from the date on which the season ticket first becomes valid.
- (B) The charges for a season ticket issued for use by a resident or local worker in
 - (i) the Kenley Road parking place; or
 - (ii) the Morden Park parking place; or
 - (iii) the Peel House Upper parking place; or
 - (iv) the York Close parking place;

- (a) subject to paragraphs (b) and (c) below, in respect of any motor car:-
 - £700 in respect of a season ticket which shall be valid for a period of 12 months running from the date on which the season ticket first becomes valid; or
 - (ii) £525 in respect of a season ticket which shall be valid for a period of 6 months running from the date on which the season ticket first becomes valid; or
 - £350 in respect a season ticket which shall be valid for a period of 3 months from the date on which the season ticket first becomes valid;
- (b) in respect of any motor car which is neither a Euro 4 compliant vehicle nor a Euro 6 compliant vehicle, the charge specified in subparagraph (a) above shall be increased by:-
 - (i) £150 for a season ticket valid for a period of 12 months running from the date on which the season ticket first becomes valid;
 - (ii) £75 for a season ticket valid for a period of 6 months running from the date on which the season ticket first becomes valid;
 - (iii) £37.50 for a season ticket valid for a period of 3 months running from the date on which the season ticket first becomes valid;
- (c) in respect of any motor car which is also a fully electric vehicle the charge shall be £20 for a season ticket valid for a period of 12 months running from the date on which the season ticket first becomes valid.

- (C) The charges for a season ticket issued for use by a resident or local worker in the Queen's Road, Wimbledon parking place shall be as follows:-
 - (a) subject to paragraphs (b) and (c) below, in respect of any motor car:-
 - £500 in respect of a season ticket which shall be valid for a period of 6 months running from the date on which the season ticket first becomes valid; or
 - (ii) £250 in respect of a season ticket which shall be valid for a period of 3 months running from the date on which the season ticket first becomes valid; or
 - (b) in respect of any motor car which is neither a Euro 4 compliant vehicle nor a Euro 6 compliant vehicle, the charge specified in subparagraph (a) above shall be increased by:-
 - (i) £75 for a season ticket valid for a period of 6 months running from the date on which the season ticket first becomes valid;
 - (ii) £37.50 for a season ticket valid for a period of 3 months running from the date on which the season ticket first becomes valid:
 - (c) in respect of any motor car which is also a fully electric vehicle the charge shall be £20 for a season ticket valid for a period of 12 months running from the date on which the season ticket first becomes valid.
- (D) The charges for a season ticket issued for use by a non-resident or nonlocal worker in
 - (i) the Elm Nursery parking place; or
 - (ii) the Raleigh Gardens parking place; or
 - (iii) the Sibthorp Road parking place;

- (a) subject to paragraphs (b) and (c) below, in respect of any motor car:-
 - £525 in respect of a season ticket which shall be valid for a period of 12 months running from the date on which the season ticket first becomes valid; or
 - (ii) £300 in respect of a season ticket which shall be valid for a period of 6 months running from the date on which the season ticket first becomes valid; or
 - £62.50 in respect a season ticket which shall be valid for a period of 1 month from the date on which the season ticket first becomes valid;
- (b) in respect of any motor car which is neither a Euro 4 compliant vehicle nor a Euro 6 compliant vehicle, the charge specified in subparagraph (a) above shall be increased by:-
 - £150 for a season ticket valid for a period of 12 months running from the date on which the season ticket first becomes valid;
 - (ii) £75 for a season ticket valid for a period of 6 months running from the date on which the season ticket first becomes valid;
 - (iii) £12.50 for a season ticket valid for a period of 1 month running from the date on which the season ticket first becomes valid:
- (c) in respect of any motor car which is also a fully electric vehicle the charge shall be £20 for a season ticket valid for a period of 12

months running from the date on which the season ticket first becomes valid.

- (E) The charges for a season ticket issued for use by a non-resident or nonlocal worker in
 - (i) the Kenley Road parking place; or
 - (ii) the Morden Park parking place; or
 - (iii) the Peel House Upper parking place; or
 - (iv) the York Close parking place;

- (a) subject to paragraphs (b) and (c) below, in respect of any motor car:-
 - £1225 in respect of a season ticket which shall be valid for a period of 12 months running from the date on which the season ticket first becomes valid; or
 - £700 in respect of a season ticket which shall be valid for a period of 6 months running from the date on which the season ticket first becomes valid; or
 - (iii) £393.75 in respect a season ticket which shall be valid for a period of 3 months from the date on which the season ticket first becomes valid:
- (b) in respect of any motor car which is neither a Euro 4 compliant vehicle nor a Euro 6 compliant vehicle, the charge specified in subparagraph (a) above shall be increased by:-
 - (i) £150 for a season ticket valid for a period of 12 months running from the date on which the season ticket first becomes valid;
 - (ii) £75 for a season ticket valid for a period of 6 months running from the date on which the season ticket first becomes valid:
 - (iii) £37.50 for a season ticket valid for a period of 3 months running from the date on which the season ticket first becomes valid;
- (c) in respect of any motor car which is also a fully electric vehicle the charge shall be £20 for a season ticket valid for a period of 12 months running from the date on which the season ticket first becomes valid.
- (F) The charges for a season ticket issued for use by a non-resident or non-local worker in the Queen's Road, Wimbledon parking place shall be as follows:-
 - (a) subject to paragraphs (b) and (c) below, in respect of any motor car:-
 - (i) £600 in respect of a season ticket which shall be valid for a period of 6 months running from the date on which the season ticket first becomes valid; or
 - (ii) £300 in respect of a season ticket which shall be valid for a period of 3 months running from the date on which the season ticket first becomes valid; or
 - (b) in respect of any motor car which is neither a Euro 4 compliant vehicle nor a Euro 6 compliant vehicle, the charge specified in subparagraph (a) above shall be increased by:-
 - (i) £75 for a season ticket valid for a period of 6 months running from the date on which the season ticket first becomes valid;

- (ii) £37.50 for a season ticket valid for a period of 3 months running from the date on which the season ticket first becomes valid:
- (c) in respect of any motor car which is also a fully electric vehicle the charge shall be £20 for a season ticket valid for a period of 12 months running from the date on which the season ticket first becomes valid.

10. Contravention

- (1) If a vehicle is left in a parking place specified in the Schedule at any time without complying with the provisions of this Order, then a contravention of this Order and a parking contravention within Part 1 of Schedule 7 to the Traffic Management Act 2004, shall be deemed to have occurred.
- (2) Where a vehicle is left in a parking place without complying with the provisions of this Order, the vehicle may be removed or caused to be removed from that parking place as provided for by Regulations made under section 99 of the Road Traffic Regulation Act 1984.
- (3) Subject to the provisions of this Order, if at any time while a vehicle is left in a parking place and no indication appears on a hand-held device that payment of the parking charge has been made using the telephone payment parking system, or an indication that the parking period for which payment was made has expired, it shall be presumed, unless the contrary is proved, that either:-
 - (a) the parking charge has not been duly paid in respect of that vehicle; or
 - (b) the parking period for which payment was made has already expired.

11. Restriction on removal of notices, tickets and permits

- (1) When a ticket or permit has been displayed on a vehicle in accordance with the provisions of Article 5(1) of this Order no person not being the driver of the vehicle shall remove the ticket from the vehicle unless authorised to do so by the driver.
- (2) Where a penalty charge notice has been attached to a vehicle no person not being the driver of the vehicle or a person authorised by the Council in that behalf shall remove the penalty notice from the vehicle unless authorised to do so by the driver.

12. Movement of vehicles left in parking places

- (1) If a vehicle is left in a parking place in a position other than in accordance with the provisions of Article 4, a person authorised by the Council in that behalf may alter or cause to be altered the position of the vehicle so that its position is in accordance with the said provisions.
- (2) For the purpose of meeting the requirements of an emergency, a person authorised by the Council in that behalf or a police constable in uniform may

- alter or cause to be altered the position of a vehicle in a parking place or remove or arrange for the removal of a vehicle from a parking place.
- (3) Any person altering or causing the alteration of the position of a vehicle by virtue of paragraphs (1) of this Article, or removing or causing the removal of a vehicle by virtue of paragraphs (2) of this Article may do so by towing or driving the vehicle or in such other manner as he may think reasonably necessary to enable the position of the vehicle to be altered or the vehicle to be removed.
- (4) Any person removing or arranging for the removal of a vehicle by virtue of paragraph (2) of this Article shall make such arrangements as they consider to be reasonably necessary for the safety of the vehicle in the place to which it is removed.
- (5) The foregoing provisions of this Article relating to the removal of vehicles shall be applied to and have equal effect for the purpose of removal of trailers, caravans, stalls or other mobile structures that are left in the parking place in contravention of Article 4.

13. Other provisions

- (1) The driver of a vehicle using a parking place shall stop the engine as soon as the vehicle is in position in that parking place, and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place.
- (2) No person shall use a vehicle, while it is in a parking place, in connection with the sale of any article (including the vehicle itself) to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services.
- (3) The driver of a vehicle using a parking place shall not sound any horn or other similar instrument except when necessary for alerting another user of the parking place in order to avoid an accident.
- (4) Except with the permission of any person duly authorised by the Council, no person shall drive any vehicle in the parking place other than for the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place
- (5) In a parking place, no person shall:
 - (a) wantonly shout or otherwise make any loud noise to the disturbance or annoyance of users of the parking place or lawful occupants of premises in the neighbourhood;
 - (b) use any threatening, abusive or insulting language, gesture or conduct with intent to put any person in fear or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned;
 - (c) use any part of a parking place or any vehicle left in a parking place:-
 - (i) for sleeping or camping purposes;

- (ii) for eating or cooking purposes;
- (iii) for the purpose of servicing, washing, cleaning, constructing, maintaining or repairing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to depart from the parking place; or
- (iv) for washing any part of his person;
- (d) loiter or remain without reasonable excuse in the parking place;
- (e) erect or cause or permit to be erected any tent, booth, stand, building or other structure without the written consent of the Council; nor
- (f) light or cause or permit to be lit any fire, stove or cooker.
- (6) Where in a parking place signs are erected or surface markings are laid for the purpose of indicating the entrance to or exit from the parking place, or indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place, no person shall drive or cause or permit to be driven any vehicle.
 - (a) so that it enters the parking place otherwise than by an entrance, or leaves the parking place otherwise than by an exit, so indicated; or
 - (b) in a direction other than that specified, as the case may be.
- (7) No person shall use a parking place as a means of vehicular passage proceeding from one road to another road or as a means of vehicular access from a road to an adjoining property without the written consent of the Council or unless in accordance with an agreement made by the Council.
- (8) Nothing in this Order shall apply to any vehicle being used for police, fire brigade or ambulance purposes.
- (9) No person shall, except with the permission of a person authorised by the Council in that behalf or in accordance with any consent or agreement with the Council or in an emergency under the direction of a police constable in uniform, drive or permit to be driven or park, or permit to be parked, any vehicle in a parking place for any purpose other than the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place or for the purpose of delivering bottles or cans or other recyclable materials for deposit in the Council's recycling facilities.
- (10) Nothing in this Order shall prevent the positioning in a parking place by the Council of containers for the deposit of empty bottles, cans or other items as may from time to time be agreed by the Council.
- (11) The driver of a vehicle using a parking place shall comply with any reasonable instruction given by a civil enforcement officer and shall where so requested park in a parking space indicated by the said officer.
- (12) No person shall empty or fill the fuel tank of any vehicle in a parking place except as is reasonably necessary to enable that vehicle to depart from the parking place, or cause or permit to wait in a parking place any vehicle leaking oil, petrol or other volatile or noxious substances.

- (13) Notwithstanding the provisions of this Order the Council may by notice displayed at or near a parking place close such parking place or part thereof for any period and no driver of any vehicle shall use such parking place or part thereof when it is so closed.
- (14) If at any time in a parking place or places or area or areas there is displayed a notice that a particular place or places or area or areas is/are reserved for use by disabled drivers or for the leaving of motor cycles, and pedal-cycles, or for the purposes of loading or unloading no person shall leave a vehicle in any such parking place or such parking area other than for the purpose so specified.
- (15) The driver of a motor vehicle using the Morden Park Car Park is not permitted to drive any vehicle without due care and consideration or in a manner likely to endanger any other person or at a speed in excess of 10 miles per hour.
- (16) The driver of a motor vehicle is not permitted to drive that vehicle into the Morden Park Car Park extension immediately adjacent the western side of the Morden Leisure Centre unless:-
 - (a) the vehicle displays a disabled badge; or
 - (b) the vehicle is an authorised vehicle.
- (17) Waiting is prohibited in the loading area in the Morden Park Car Park extension unless the vehicle is an authorised vehicle waiting for the purpose of loading or unloading for a maximum period of 20 minutes.
- (18) Vehicles which display in the relevant position a disabled persons badge are prohibited from waiting in the Morden Park Car Park extension for more than three hours.
- **14.** Where a vehicle has been left in a parking place or a car park without marked parking spaces and payment is made using the telephone payment parking system, an indication that payment has been made and the parking period for which payment has been made shall appear on a hand-held device.
