#### PROPOSED CONVERSION OF PARKING PLACE TO WAITING RESTRICTION IN LINCOLN AVENUE, WIMBLEDON

## THE MERTON (PARKING PLACES) (VNE) (AMENDMENT NO. \*) ORDER 202\*

- 1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Merton under the powers conferred by sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, propose to make the above mentioned Order.
- 2. The general effect of the Order would be to convert three existing parking places in Lincoln Avenue, the east side, outside No. 3 Lincoln Avenue to single yellow line waiting restriction operating Mondays to Fridays between the hours of 10am and 4pm to facilitate proposed vehicle crossovers.
- 3. A copy of the proposed Order and other documents giving more detailed particulars of the Order, including a plan which indicates the road or length of road to which the Order relates, can be inspected Mondays to Fridays during normal office hours at Merton Link, Merton Civic Centre, London Road, Morden.
