Annex 2

Conditions consistent with the Operating Schedule

1. All staff shall receive regular training on the responsible sale of alcohol every 6 months and a record of this training shall be kept on the premises.
2. The age at which the age verification policy required by the mandatory condition attached to this licence is set, shall be 25 years of age (Challenge 25), in that anyone who appears to be aged 25 years or under shall be required to produce appropriate evidence as stated in the policy to prove they are 18 years of age or over.
3. CCTV equipment shall be installed and working at all times the premises are open for licensable activities.
4. Advice shall be taken from the Police regarding the external use of CCTV.
5. CCTV images shall be retained for at least twenty eight days and shall be produced to an authorised officer of the council or the Police within a reasonable time frame subject to data protection legislation.
6. An incident log shall be kept of all instances of crime and disorder; this is to include all refusals of alcohol. The record must show the date, time, member of staff details and a brief record of the incident.
7. Waste/rubbish that can be attributed to the premises shall be removed from the front of the premises.
8. Lighting shall be provided outside the premises and in the private car park during the hours of darkness when any licensable activity takes place on the premises.
9. To minimise disturbance to nearby properties, all rubbish will be taken outside at a reasonable time.
10. Prominent, clear and legible notices shall be displayed at all exits requesting patrons to respect the needs of local residents and to leave the premises and the area quietly.
