

Proposed Controlled Parking Zone (CPZ) GC3 Edgehill Road Area

Dear Resident/Business,

This leaflet is to update you of the outcome of the statutory consultation that was carried out between 17 October and 15 November 2019 on the proposals to introduce a Controlled Parking Zone (CPZ) GC3 Edgehill Road Area to include Beechholme Avenue, Caithness Road, Edgehill Road, Elmhurst Road, Garden Avenue, Hill Road, Melrose Avenue, Park Avenue, Ridge Road and Streatham Road (between entrance to Mitcham Industrial Estate and its junction with Ridge Road).

The statutory consultation resulted in 135 representations (some residents sent several representations which have been included within the 135 representations). There are 16 representations in support; 10 comments and 90 against the proposed CPZ. All representations received during the statutory consultation along with officer's recommendations were reported to the Cabinet Member for Regeneration, Transport and Housing in January 2020. After careful consideration the following have been agreed:

- To proceed with making of the Traffic Management Orders (TMOs) and the implementation of the proposed GC3 to include Beechholme Avenue, Caithness Road, Edgehill Road, Elmhurst Road, Garden Avenue, Hill Road, Park Avenue, Ridge Road and Streatham Road (between entrance to Mitcham Industrial Estate and its junction with Ridge Road) operational Monday to Friday between 8.30am and 6.30pm as shown in Drawing No. Z78-354-02 and attached in Appendix 1.
- To proceed with making of the TMOs to introduce electric charging points in St Barnabas Road, Edenvale Road and Streatham Road.
- Not to proceed with making of the Traffic Management Order for the introduction of a CPZ in Melrose Avenue in GC3.
- To proceed with the making of the relevant Traffic Management Orders (TMOs) and the implementation of the 'At any time' waiting restrictions within the proposed zone.
- To exercise his discretion not to hold a public inquiry on the consultation process.

What happens next

The final made TMO, which allows the restrictions to be implemented and administered, will be published in the London Gazette and the local newspaper shortly. Notices will also be placed on lamp columns in the affected areas. It is anticipated that the CPZ will come into operation on **4 April 2020**. Dear Resident / Business

Following the Council's decision to introduce the GC3 CPZ in Edgehill Road area, I am writing to inform you that the works will start on 09 March 2020, and will be carried out by F M Conway Ltd on behalf of the Council.

DATE AND TIME OF WORKS

The works including street cleansing are programmed to start the week commencing 09 March 2020 for a period of 2 weeks, weather permitting. Work will be carried out between 8am and 4.30pm. To allow the works to be carried out as quickly as possible, temporary parking restrictions will be introduced. "No Parking" cones and signs will be in place to indicate the areas where parking would be prohibited. By doing so, this will keep the roads free of parked vehicles allowing a smooth transition of the works. Vehicles would be allowed back into the road to park once the lining work is complete or after the working day. Offending vehicles run the risk of receiving a fine and possible relocation.

Notices and cones will be placed in your road 12 – 24hrs prior to work being undertaken.

SCHEDULE OF WORKS: The work schedule of when your road will be marked is shown below.

- Ridge Road and Caithness Road - 9 March
- Park Avenue and Hill Road - 10/11 March
- Garden Avenue - 12 March
- Elmhurst Avenue and Beechholme Avenue - 13 March
- Edgehill Road - 16 March
- Streatham Road - 17 March

The information pack on how to apply for your permit will follow shortly (except for Melrose Avenue which is to be excluded from the zone). It is essential that you apply for all your permits within 2 months of the implementation of the CPZ. After this date you will need to pay the new permit charges.

The Council is conscious of the inconvenience and the disruption these works may cause and will endeavour to keep the impact to a minimum. We apologise in advance for any inconvenience.
