Dear Resident / Business

Following the Council's decision to introduce the WB2 CPZ in Cavendish Avenue, I am writing to inform you that the works will start on 26 March 2018, which will be carried out by F M Conway Ltd on behalf of the Council.

DATE AND TIME OF WORKS

The works including street cleansing are programmed to start the week commencing 26 March 2018 for a period of 3 days, weather permitting. Work will be carried out between 8am and 4.30pm. To allow the works to be carried out as quickly as possible, temporary parking restrictions will be introduced. "No Parking" cones and signs will be in place to indicate the areas where parking would be prohibited. By doing so, this will keep the roads free of parked vehicles allowing a smooth transition of the works. Vehicles would be allowed back into the road to park once the lining work is complete or after the working day. Offending vehicles run the risk of receiving a fine and possible relocation. Notices and cones will be placed in your road 12 – 24hrs prior to work being undertaken.

SCHEDULE OF WORKS: The work schedule of when your road will be marked is shown below.

- Cavendish Avenue, **26 March**.
- Belmont Avenue, Errol Gdns and Barnard Gardens, **27 March**.

The Council is conscious of the inconvenience and the disruption that this work may cause and will endeavour to keep the impact to a minimum. Dear Resident / Business

This leaflet is to update the community of the outcome of the statutory consultation that was carried out between 4 December 2017 and 5 January 2018 on the proposals to introduce WB2 Controlled Parking Zone (CPZ) in Cavendish Avenue operational Monday to Friday between 10am and 4pm and waiting restrictions in Belmont Avenue, Errol Gardens and Barnard Gardens.

The statutory consultation resulted in 8 representations received which include 2 objections and 6 comments. All representations received during the statutory consultation along with officer's recommendations were reported to the Cabinet Member for Regeneration, Environment and Housing in February 2018. After careful consideration the following have been agreed:

- To proceed with making of the Traffic Management Orders (TMOs) implementation of a new CPZ WB2 operational Monday to Friday between 10am – 4pm in Cavendish Avenue.
- To proceed with the making of the Traffic Management Orders (TMOs) to introduce yellow line restrictions in Barnard Gardens, Belmont Avenue and Errol Gardens.

What happens next

The final made TMO, which allows the restrictions to be implemented and administered, will be published in the London Gazette and the local newspaper shortly. Notices will also be placed on lamp columns in the affected areas. It is anticipated that the CPZ will come into operation on **16 April 2018**.
