

**PROPOSED PROVISION OF CYCLE HIRE PARKING PLACES IN VARIOUS ROADS**

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Merton propose to make the above-mentioned Orders under the powers conferred by 6, 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended and all other enabling powers.
2. The general effect of the 'Cycle Hire Parking Places' Order would be to designate a parking place on the carriageway in the lengths of road specified in the Schedule to this notice for the leaving of electric assisted pedal cycles being used in a public hire scheme operated under an agreement with the Council.
3. The general effect of the other 'Parking Places' Orders would be to remove existing lengths of parking place in the lengths of road specified in the Schedule to this notice to accommodate the introduction of cycle hire parking places.
4. A copy of the proposed Orders and other documents giving more detailed particulars of the Orders, including plans which indicate the roads or lengths of road to which the Orders relate, can be inspected Monday to Friday during normal office hours at Merton Link, Merton Civic Centre, London Road, Morden. 5. 2.	GRAHAM ROAD, SW19; the north-east side, from a point 1.1 metres north-west of the south-eastern boundary of No. 110 Graham Road, north-westward for a distance of 5.5 metres.	W4
3.	GRAHAM ROAD, SW19; the south-east side, from a point 19.3 metres south-west from the south-western kerb-line of Hartfield Road, south-westward for a distance of 5.5 metres.	W4
4.	PALMERSTON GROVE, SW19; the south-east side, from a point 11.4 metres north-east of the north-eastern kerb-line of Palmerston Road, north-eastward for a distance of 5 metres.	W4
5.	RIDLEY ROAD, SW19; the north side, from a point 8.6 metres west of the western kerb-line of Wycliffe Road, westward for a distance of 5 metres.	3F
6.	SOUTH PARK ROAD, SW19; the north-east side, from a point 2 metres south-east of the party wall between No. 15 Queens Road and the police station, north-westward for a distance of 5 metres.	W3
