THE MERTON (PARKING PLACES) (RPC1) (AMENDMENT NO. *) ORDER 202*

- 1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Merton propose to make the above-mentioned Order under sections 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the "Parking Places" Order would be to replace the length of parking place described in the Schedule to this notice with a single yellow line waiting restriction operating between the hours of 12 noon and 1pm Mondays to Fridays.
- 3. A copy of the proposed Order and other documents giving more detailed particulars of the Order, including a plan which indicates the road or length of road to which the Order relates, can be inspected Mondays to Fridays during normal office hours at Merton Link, Merton Civic Centre, London Road, Morden.
