 - Introduce 'at any time' waiting and loading restrictions at various locations across the borough;
 - To replace existing single yellow line in Havelock Rd with a parking space.
 - To convert an existing P&D bay in Abbotsbury Rd to motorcycle parking bay to facilitate the demand and remove antisocial parking.
- 2) Notes and considers the representations received in respect of the proposals as detailed in Appendix 2.
- 3) Agrees to proceed with the making of the relevant Traffic Management Orders (TMOs) and the implementation of the proposed measures as shown in Drawing Nos. Z27-695-03 – 26 (see Appendix 1).
- 4) In line with feedback received, agrees to a further statutory consultation in Woodland to introduce waiting restrictions on the other side of the road what was previously consulted on.
- 5) Agrees to exercise his discretion not to hold a public inquiry on the consultation process.
