Proposed waiting restrictions (double yellow lines) Fern Road – statutory consultation

The Council has received complaints from the community regarding obstructive and dangerous parking along Fern Road. In response to these reports the Council is proposing to introduce waiting restrictions (double yellow lines) to address obstructive parking and assist with movement of traffic.

Please see the attached plan, overleaf, to illustrate the proposed extents of the double yellow lines.

WHAT HAPPENS NEXT

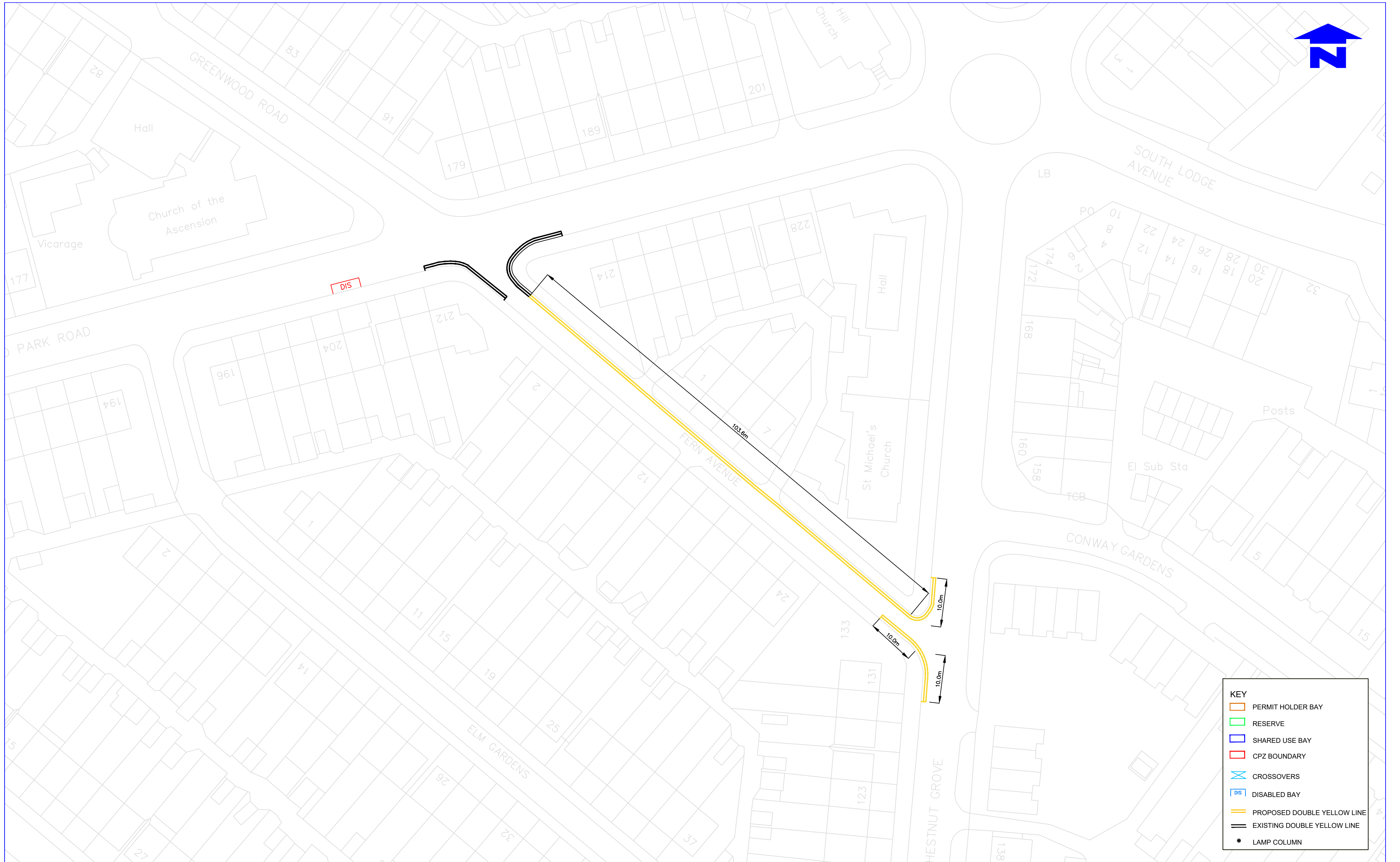
