Proposed waiting restrictions (double yellow lines) Rectory Close – statutory consultation

The Council has received complaints from the community regarding obstructive and dangerous parking in Rectory Close at the cul de sac end. In response to these complaints the Council is proposing to introduce waiting restrictions (double yellow lines) to address obstructive parking and assist with movement of traffic.

Please see the attached plan, overleaf, to illustrate the proposed extents of the double yellow lines.

WHAT HAPPENS NEXT

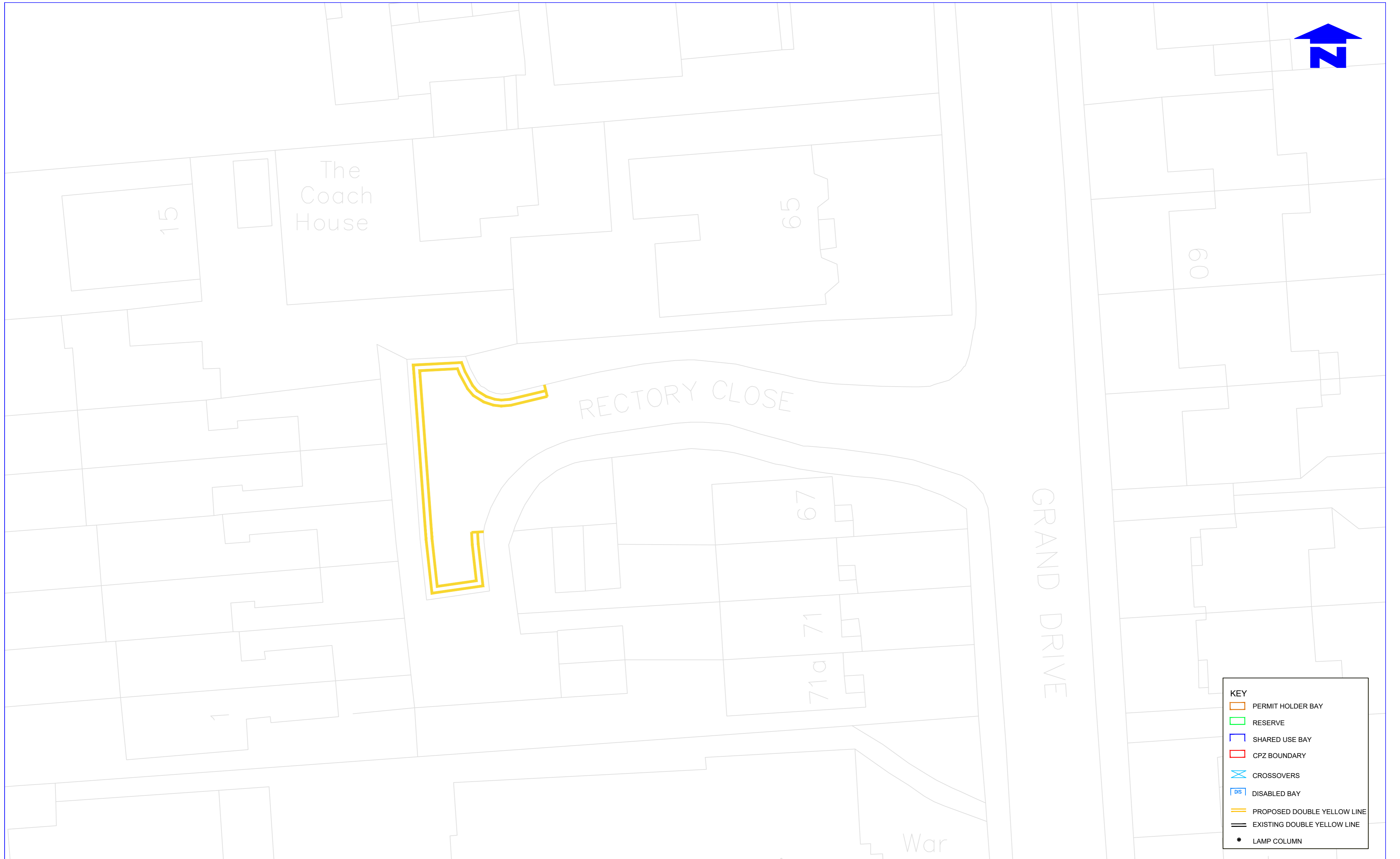
