Dear Resident/Business,

The purpose of this leaflet is to let you know the outcome of the statutory consultation that was carried out in June / July 2013, and to inform you of the Council's decision on the proposed measures to introduce a new Controlled Parking Zone (CPZ) for the A1 Apostles area, as shown on the enclosed plan.

The representations received along with officers' recommendations were reported to Street Management Advisory Committee and the Cabinet Member for Environmental Sustainability and Regeneration on 29th January 2014. After Careful consideration the following have been agreed:

- To proceed with the making of the Traffic Management Orders (TMOs) for the inclusion of Abbott Avenue, Bronson Road, Chestnut Road, Dupont Road, Kingston Road - Property Nos. 348 to 540 (even numbers), Kingston Road - Property Nos. 427 to 581 (odd numbers) into the new A1 Apostles CPZ, which will be operational Mondays to Fridays (inclusive) between 8.30am to 6.30pm.
- To proceed with the making of the Traffic Management Order (TMO) for the implementation of single and double yellow lines waiting restrictions and loading restrictions at key locations such as junctions, bends, cul de sacs.

WHAT HAPPENS NEXT

The final made Traffic Management Orders (TMOs), which allows the restrictions to be implemented and administered, will be published in the London Gazette and the local newspaper shortly. Notices will also be placed on lamp columns in the affected area.

It is anticipated that the CPZ will come into operation on 14 April 2014.

Dear Resident / Business

Following the Council's decision to introduce a Controlled Parking Zone (A1 CPZ) in the Apostles Roads, I am writing to inform you that the works will start shortly, which will be carried out by F M Conway Ltd on behalf of the Council.

DATE AND TIME OF WORKS

It is anticipated that the works will start the week commencing 17 March 2014 for a period of approximately 2 weeks, weather permitting. Each road within the zone will be implemented in the order detailed in the schedule below but may be subject to change if the weather prevents the contractor from carrying out the works. All works will be carried out between 9am and 4.30pm.

While work is being undertaken in your street, we request that you park in the existing RP CPZ and display the yellow cards provided (only use the cards on the date work is taking place in your road) on the dashboard of your vehicle. By doing so, this will keep the roads free of parked vehicles to allow a smooth progression of the works. Vehicles would be allowed back onto the road once the lining work is complete or after the working day. Offending vehicles run the risk of receiving a fine and possible relocation, should they park during the restricted times.

To allow for the works to be carried out as quickly as possible, "No Parking" cones and signs will be in place to indicate the areas where parking would be prohibited and notices and cones will be placed in your road 12 – 48 hours prior to work being undertaken.

The information pack on how to apply for your permit will follow shortly. The Council is conscious of the inconvenience and the disruption that this work may cause and will endeavour to keep the impact to a minimum. We apologise in advance for any inconvenience that may be caused by these works.
