ENFORCEMENT NOTICE - MATERIAL CHANGE OF USE

ISSUED BY THE LONDON BOROUGH OF MERTON

1. **THIS IS A FORMAL NOTICE** issued by the Council because it appears that there has been a breach of planning control under Section 171A(1)(a) of the above Act, at the land described below. The Council considers it expedient to issue this notice, having regard to the provisions of the development plan and to other material considerations.

2. **THE LAND AFFECTED**

Land at 26 Walpole Road, Colliers Wood, London SW19 2BZ , in the London Borough of Merton shown edged red on the attached plan.

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without planning permission change of use from a single dwelling house to use as separate self contained flats

4. **REASONS FOR ISSUING THIS NOTICE**

It appears to the Council that the above breach of planning control has occurred within the last four years.

The unauthorised use negatively affects the amenities of the residents of the properties and provides substandard accommodation, contrary to Policies HS.1 and HP.5 of the adopted Unitary Development Plan (October 2003) and Supplementary Planning Guidance Notes on Residential Extensions, Alterations and Conversions, November 2001

The unauthorised conversion works negatively affect the amenities of the residents of the neighbouring properties by causing visual intrusion, noise disturbance and lack of parking capacity contrary to policies BE.15 and PK2

Copies of the above policies are attached.

5. **WHAT YOU ARE REQUIRED TO DO**

(a) To cease the use of the premises as self contained flats and revert to use as a single dwelling house

(b) remove the rear door at first floor level and reinstate the window to its dimensions prior to its removal

(c) remove two of the kitchens

Time for Compliance: 6 months from the date this notice takes effect.

6. **WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on 29 December 2008 unless an appeal is made against it beforehand.
