1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under section 171A(1)(a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations.

2. THE LAND AFFECTED

The land and property known as Date Valley School, Mitcham Court, Cricket Green, Mitcham CR4 4LB shown edged red on the plan attached ("the Premises")

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without planning permission the erection of a shelter ['the Unauthorised Structure'] in the playground of the Premises

4. REASONS FOR ISSUING THIS NOTICE

- 1) The Unauthorised Structure has not existed for more than four years.
- 2) The 'Unauthorised Structure' by reason of its size, siting and design fails to preserve or enhance the appearance of the Mitcham Cricket Green Conservation Area contrary to Policies DM D2 Design considerations in all developments and DM D4 Managing heritage assets of Merton's Sites and Polices Plan 2014, CS14 Design of the Merton's Core Planning Strategy adopted July 2011 and 7.4 Local Character, 7.6 Architecture & 7.8 Heritage assets and archaeology of the London Plan 2011.

5. WHAT YOU ARE REQUIRED TO DO

- a) Demolish the Unauthorised Structure
- b) Remove all resultant debris from the Premises as a result of compliance with the requirement of step 5(a) above

6. TIME FOR COMPLIANCE

Three calendar months after this notice takes effect.

7. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 25th May 2016, unless an appeal is made against it beforehand.
