## ENFORCEMENT NOTICE - OPERATIONAL DEVELOPMENT

Planning Development Control ISSUED BY THE LONDON BOROUGH OF MERTON

THIS IS A FORMAL NOTICE issued by the Council because it appears that there 1. has been a breach of planning control under Section 171A(1)(a) of the above Act, at the land described below. The Council considers it expedient to issue this notice, having regard to the provisions of the development plan and to other material considerations.

#### THE LAND AFFECTED 2.

Land at 8 Lower Downs Road, Raynes Park, London, SW20 8QF in the London Borough of Merton shown edged red on the attached plan ('the Land').

#### THE BREACH OF PLANNING CONTROL ALLEGED 3.

The erection, without planning permission, of a wooden fence boundary and gate measuring more than 1m in height adjacent to a highway at 8 Lower Downs Road, Raynes Park, London SW20 8QF.

#### REASONS FOR ISSUING THIS NOTICE 4.

- It appears to the Council that the above breach of planning control has (a) occurred within the last four years.
- The erection of the wooden fence boundary and gate is contrary to the (b) following policy of the Merton Unitary Development Plan (Adopted October 2003)

BE.22 Design of New Development

A copy of the above policy is attached.

# WHAT YOU ARE REQUIRED TO DO 5.

Remove the fence at the front of the house, adjacent to Lower Downs Road (a) and Ethelbert Road

or

Reduce the height of the fence at the front of the house adjacent to Lower (b) Downs Road and Ethelbert Road to no more than 1 metre high so that it complies with permitted development rights

Time for Compliance: within 1 month from the date this notice takes effect.

#### YOUR RIGHT OF APPEAL

You can appeal against this notice by using the Enforcement Notice Appeal forms online submitting an appeal this notice or by enclosed with (www.planningportal.gov.uk/pcs). Please note however that any appeal must be received, or posted in time to be received, by the Planning Inspectorate before the date this notice takes effect. The enclosed booklet "Making Your Enforcement Appeal" sets out your rights and the procedure to be followed. Read it carefully. You should also read sections 171-177 of the Act which are also enclosed. If you decide to appeal, you should send two copies of the enclosed appeal forms and one copy of the enforcement notice, to the Planning Inspectorate. The other appeal form and the other copy of the enforcement notice are for you to keep for your own records.

### FEE PAYABLE FOR THE DEEMED APPLICATION

If your ground of appeal is, or includes ground (a) that planning permission should be granted, you must include with your appeal a fee, which is double that payable for a normal planning application. The total fee payable is  $\pounds 300$ .

Half the fee is payable to the Planning Inspectorate and half to the Council.

You should therefore send:

One cheque for £150 payable to 'DCLG' to the Planning Inspectorate

One cheque for £150 payable to 'London Borough of Merton' to the Council

The fee can be sent with your appeal form.

# WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this enforcement notice, it will take effect on the date indicated above and you must then ensure that the notice is complied with. Failure to comply with an enforcement notice that has taken effect, is a criminal offence and can result in legal proceedings and/or remedial action by the Council.
