The Council of the London Borough of Merton, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 45, 46 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a), as amended by section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985(b) and of all other powers thereunto enabling, hereby make the following Order:-

PART I - PRELIMINARY

Citation and commencement

1. This Order may be cited as the Merton (Parking Places) (Parking Charges) Order 202* and shall come into force on * 202*.

Interpretation

2. In this Order "enactment" means any enactment whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

Amendments to Various Orders

- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order:-
 - (a) the Orders specified in Schedule 1A to this Order shall have effect as though:-

Half-day permits relating the roads listed in Part 2 of Schedule 1 to this Order shall be valid on one day only but only for those hours of the permitted hours that fall either between 8.30 am and 2.00 pm Mondays to Saturdays or between 12:00 pm and 6.30 pm Mondays to Saturdays. PART 2

For the purposes of and subject to the provisions of this Order, the Merton vehicle band that applies to a vehicle shall be determined in accordance with the following Provisions of this Part:-

- (1) Where reference is made in this Part to the quantity of carbon dioxide (CO2) gas emitted by a vehicle, the quantities shall be taken to be those which are specified on the UK registration certificate issued in respect of that vehicle.
- (2) In relation to a passenger vehicle the registration date of which is 1st March 2001 or later, the Merton vehicle band shall be deemed to be that specified in column (3) of

an item in the Table of this Appendix where the quantity of carbon dioxide (CO2) gas emitted by the vehicle, measured in grams per kilometre driven (g/km), falls within the range of values set out in column (2) of that item:

Provided that in relation to a passenger vehicle the registration date of which is before 1st March 2001, the Merton vehicle band shall be deemed to be band M.

(3) In relation to a light goods carrying vehicle, the Merton vehicle band shall be deemed to be that specified in column (3) of an item in the Table of this Appendix where the quantity of carbon dioxide (CO2) gas emitted by the vehicle, measured in grams per kilometre driven (g/km), falls within the range of values set out in column (2) of that item:

Provided that where the registration certificate does not specify the quantity of carbon dioxide (CO2) gas emitted by the vehicle, measured in grams per kilometre driven (g/km), the Merton vehicle band of that vehicle shall be deemed to be Merton vehicle band M.

(4) Where the vehicle is an electric vehicle or a fuel cell vehicle, the Merton vehicle band shall be deemed to be Merton vehicle Band A.

SCHEDULE 3

"Diesel vehicle" includes hybrid vehicles which use diesel as a fuel source;

"Euro 4 compliant vehicle" means a petrol vehicle in respect of which there is issued a valid UK registration document or foreign registration document on which the vehicle's exhaust emissions specified are those below the limits set for compliance with the Euro 4 emissions standard set out in the rows corresponding with Category B in the first of the tables at section 5.3.1.4 of Annex I to Council Directive 70/220/EEC on type approval of motor vehicles which respect to emissions from light passenger vehicles and on access to vehicle repair and maintenance information or a petrol vehicle for which the Council has obtained information from the Vehicle Certification Agency which shows the vehicle meets the Euro 4 emissions standard:

"Euro 6 compliant vehicle" means a diesel vehicle in respect of which there is issued a valid UK registration document or foreign registration document on which the vehicle's exhaust emissions specified are those below the limits set for compliance with the Euro 6 emissions standard set by Regulation (EC) No. 715/2007 of the European Parliament and of the Council of 20 June 2007 on type approval of motor vehicles with respect to emissions from light passenger and commercial vehicles (Euro 5 and Euro 6) and on access to vehicle repair and maintenance information or a diesel vehicle for which the Council has obtained information from the Vehicle Certification Agency which shows the vehicle meets the Euro 6 emissions standard;

"fuel cell vehicle" means a vehicle in which the electrical motive power is derived from hydrogen and which is not connected to any source of power derived from fossil fuel when the vehicle is in motion;

"light commercial vehicle" means a vehicle type approved as a category N1, class I, II or III vehicle (vehicles designed and constructed for the carriage of goods and having a maximum mass not exceeding 3.5 tonnes) within the meaning of Annex II of Council Directive 2007/46/EC:

"light passenger vehicle" means a vehicle type approved as a category M1 vehicle (vehicle with at least four wheels used for carriage of passengers and comprising no more than 8 seats in addition to the driver's seat) within the meaning of Annex II of Council Directive 2007/46/EC;

"Merton vehicle band" means either Band A, Band B, Band C, Band D, Band E, Band F, Band G, Band H, Band I, Band J, Band K, Band L or Band M which is allocated to a vehicle under the provisions of Article 2(5) and Appendix A, for the purposes of determining the charge for a business permit, residents' permit, teacher permit or trade permit:

"petrol vehicle means a vehicle in which the motive power is wholly or partially derived directly or indirectly from an internal combustion engine with spark-ignition designed to run on petrol and includes hybrid vehicles which use petrol as a fuel source:

"registration date", in relation to a vehicle, means the date of first registration of that vehicle as specified on the UK registration certificate issued in respect of that vehicle;

"UK registration certificate" means a current registration document issued to a vehicle in the United Kingdom under the provisions of Regulation 10(4) and 10A of the Road Vehicles (Registration and Licensing) Regulations 2002.
