CHANGES TO ON-STREET PARKING PLACES PAY AND DISPLAY CHARGES CHANGES TO RESIDENTS PERMITS, BUSINESS PERMITS, TEACHER PERMITS, TRADER PERMITS, ANNUAL VISITOR PERMITS AND TEMPORARY VISITOR PERMITS CHARGES

### THE MERTON (PARKING PLACES) (PARKING CHARGES) ORDER 202\*

- NOTICE IS HEREBY GIVEN that the Council of the London Borough of Merton, propose to make the above-mentioned Order under sections 45, 46 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the Order would be to:-
  - (a) increase the existing pay and display/pay by phone/pay on-line charges by £1.50 for any vehicle not meeting the Ultra Low Emission Zone (ULEZ) emission standards, ie:-
    - (i) any petrol vehicle which does not meet the vehicles emission standard EURO 4 (most petrol vehicles first registered before 2006);
    - (ii) any diesel vehicle which does not meet the vehicles emission standard EURO 6 (most diesel vehicles first registered before September 2015);
  - (b) for resident permits, business permits, teacher permits or trade permits, remove the £150 diesel surcharge and replace it with a ULEZ based charge of £150 which would apply to the purchase of a resident permit, business permit, teacher permit or trade permit for use by any vehicle not meeting the ULEZ emission standards;
  - (c) vary the standard charge for resident permits so that they would be charged on a carbon dioxide emission based sliding charge as specified in the table in Schedule 1 to this notice, subject to paragraph (b) above and increasing by an additional £50 for each subsequent permit. Vehicles to which emission banding does not apply (e.g. those registered pre-March 2001) would pay the charge of the highest band applicable.
  - (d) vary the full and half day temporary visitor permit charges to the daily charges specified in the table in Schedule 2 to this notice for scratch cards and e-permits, subject to an additional charge of £1.50 for vehicles which do not meet the ULEZ emission standards. Vehicles to which emission banding does not apply would pay the charge to the highest band applicable;
  - (e) vary the annual visitors permit to that shown in the table in Schedule 3 to this notice;
  - (f) vary the business permit charges to the emission based sliding charges shown in Schedule 4 to this Order, subject to the ULEZ based charge (£75 for a 6 month business permit) where applicable. Vehicles to which emission banding does not apply would pay the charge to the highest band applicable;
  - (g) vary the teacher permit charges to the emission based sliding charges for an annual teacher permit shown in Schedule 5 to this Order, subject to the annual £150 ULEZ based charge (or £50 per term) where applicable. Vehicles to which emission banding does not apply would pay the charge to the highest band applicable;
  - (h) vary the trade permit charges to the emission based sliding charges for an annual trade permit shown in Schedule 5 to this Order, subject to the annual £150 ULEZ based charge where applicable (£75 for a 6 month trade permit, £37.50 for 3 month trade permit, £12.50 for 1 month permit and £2.85 for 1 week trade permit) where applicable. Vehicles to which emission banding does not apply would pay the charge to the highest band applicable.
  - NB 1:permits issued for a duration of other than a year would be subject to the charge on a prorata basis;
  - NB 2: payment for pay and display parking places via mobile or via the internet would continue to incur a 20 pence convenience fee.
  - NB 3: any pay and display parking places with the first 20 or 30 minutes free, would continue to have the first 20 or 30 minutes free.
  - NB4: in Schedules 2, 4 and 5 to this notice, the current charges for various permits can be found in column 8 and match Band G charges.
