Planned footway improvements The Path, Morden

Dear Resident / Business,

The purpose of this newsletter is to inform you that the Council will be carrying out some footway improvements in The Path near its Junction with Morden Road, as shown on the plan overleaf.

These improvements will create better use of this open space making it more attractive and a safer route for pedestrians and cyclists.

The proposed improvements include the following:

- Build out of the junction to provide a safer crossing for pedestrians
- Rain garden watered by diverting surface water from the adjacent carriageway.
- Diverting cyclists on to the road discouraging them from using the footway.
- · Footway surfacing
- New plants and trees

Please note that the proposed improvements do not require a consultation. The ward councillors and interest group representing residents have commented on the proposals.

What happens next

The implementation of the proposed improvements is planned to commence in March 2020. You will receive a separate letter with details of the precise dates, times and temporary traffic management arrangements.
