Recommendations:

It is recommended that the Cabinet Member for Environmental Sustainability & Regeneration:

- 1. Notes that no objections were received as a result of the statutory consultation carried out between 17 November and 9 December 2011 on proposals to:
- a) introduce a min roundabout on a raised junction table at the Gap Road/Ashcombe junction
- b) amend waiting and loading restrictions in the vicinity of the same junction.
- 2. Agrees to the introduction of a mini roundabout at the junction of Gap Road and Ashcombe Road and the making of the relevant Traffic Management Orders to introduce the necessary Waiting and Loading restrictions around the junction as shown on plan Z38-115-02 attached as appendix 1.

1 PURPOSE OF REPORT AND EXECUTIVE SUMMARY

1.1. This report informs the Cabinet Member for Environmental Sustainability & Regeneration of the outcome of a statutory consultation carried out between 17 November and 9 December 2011, on a traffic management proposal to introduce a mini roundabout on a raised speed table and associated changes to the waiting and loading restrictions around the junction of Gap Road and Ashcombe Road. The report seeks approval to implement the proposals as shown on plan Z38-115-02 attached as appendix 1

2 DETAILS

- 2.1. In August 2011, the Council identified Gap Road / Ashcombe Road junction as a potential site for a road safety scheme.
- 2.2. Accident investigation for the 3 year period leading upto 27 February 2011 revealed two separate accidents at the junction which had given rise to one serious and one slight injury. Both incidents were identical in that they involved right turning vehicles cutting across the path of motorcyclists travelling straight

ahead. A third accident of the same nature is also on record some 20 metres from the main junction and resulted in a 'Slight' personal injury to the motorcyclist. Additionally, over the years, officers had received a number of complaints regarding the operation of this junction. Given the nature of the accidents it is considered appropriate to reduce the speed of traffic on approach to the junction and ease right turning drivers through the installation of a mini roundabout.

- 2.3. Site observations confirm that right turning vehicles both out of and in to Ashcombe Road often face difficulty as a result of being the minor arm within the current configuration of the junction. This is due to the fact that Gap Road carries a considerable volume of traffic at a higher speed than expected. This often results in drivers compromising safety by attempting to make a manoeuvre within small gaps in the main flow of traffic.
- 2.4. In order to slow traffic and to assist the various manoeuvres at the junction it is proposed to introduce a speed table and a mini roundabout. This proposal was discussed with ward councillors who agreed with the concept of the scheme and their comments are detailed in section 3.4 of this report.
- 2.5. For the safe operation of the junction and the mini roundabout it is necessary to convert some existing single yellow line restrictions to double yellow lines and to extend the restrictions. Please see plan Z38-115-02 attached as appendix 1 for the extent of the proposed restrictions.
- 2.6. It is believed that traffic flow will not be adversely affected by the proposals.

3 CONSULTATION

- 3.1. The statutory consultation for the speed table and the waiting restrictions commenced on 17th November 2011 and concluded on 8th December 2011. The statutory consultation consisted of posting a newsletter (attached as appendix 2) to 36 premises within close proximity of the proposed measures. Notices advertising the changes to Waiting/Loading and proposed raised junction table was published in the local newspapers and erected on lamp columns in the area. The information was also made available at Merton Link, Wimbledon Library and the Council's website.
- 3.2. The consultation did not result in any objections being received from residents.
- 3.3. Emergency Services and other statutory bodies were also consulted. One response was received from the Police who commented that they had no objection to the proposals.
- 3.4. Ward councillors were also informed about the scheme prior to the start of the consultation. 2 ward councillors responded and their comments are given below:
 - I have looked through this and it seems like a good proposal to me of which I am supportive.
 - I confirm that I too am supportive. I am aware of accidents at this junction and hope that these measures may help to reduce the problems. Many thanks for the briefing and notification of the proposals.

4 ALTERNATIVE OPTIONS

4.1. Do Nothing. This would do nothing to address the identified safety issues at the junction.

5 TIMETABLE

5.1. If approved, the scheme will be implemented during the first week of January 2012.

6 FINANCIAL, RESOURCE AND PROPERTY IMPLICATIONS

6.1. The cost of the proposed works is estimated at £55,000 which is to be met from the 'Local Safety' budget provided by TfL.

7 LEGAL AND STATUTORY IMPLICATIONS

- 7.1. The TMO for the introduction of waiting restrictions will be made under Section 6 of the Road Traffic Regulation Act 1984.
- 7.2. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft order. The contents of this report fulfil these obligations.
- 7.3. All road markings and signage will be in accordance with TSRGD 2002.

8 HUMAN RIGHTS, EQUALITIES AND COMMUNITY COHESION IMPLICATIONS

8.1. The implementation of the proposals will affect sections of the community especially local residents who will benefit from the environmental improvements in the area and the improved safety for all road users.


