Dear Resident / Business,

The purpose of this consultation document is to seek your views on proposals to implement double yellow lines restrictions. The Council carries out careful consultation to ensure that all road users are given a fair opportunity to give their views on the parking proposals. The parking needs of the residents and visitors are given consideration but it is considered that maintaining safe access must take priority.

The measures will help to improve safety for all road users and will ensure that access is maintained at all times. The proposed waiting restrictions will improve visibility and provide clear access for all road users particularly vulnerable road users such as pedestrians, push chairs and wheelchair users who for example may wish to make proper use of the section of dropped kerb at junctions.

## PROPOSED MEASURES

It is proposed to implement double yellow line waiting restrictions in the Bungalows at its junction Streatham Road with The Bungalows outside 4 and 15. The proposed measures are shown on the plan overleaf.

## WHAT HAPPENS NEXT

A Notice of the Council's intentions to make the relevant Traffic Management Orders (TMOs) for the required changes will be published in the local newspaper (The Guardian), London Gazette and posted on lamp columns in the vicinity. Representations for and against the proposals must be done in writing to the Head of Street Scene and Waste Management Division, Merton Civic Centre, London Road, Morden, Surrey, SM4 5DX or email [trafficandhighways@merton.gov.uk](mailto:trafficandhighways@merton.gov.uk) by no later than 3 July 2015 quoting reference PO12-15.

Objections must relate only to the elements of the scheme that are subject to this statutory consultation. The Council is required to give weight to the nature and content of your representations and not necessarily the quantity. Your reasons are therefore important to us.

All representations along with Officers' comments and recommendations will be presented in a report to the Cabinet Member for Environmental Sustainability and Regeneration. Please note that responses to any representations received will not be made until a final decision is made by the Cabinet Member. Once a decision is made you will be informed accordingly.

Copies of the proposed Traffic Management Order (TMO), a plan identifying the area affected by the proposal and the Council's 'Statement of Reasons' can be inspected at the Merton Link, Merton Civic Centre, London Road, Morden, Surrey, during the Council's normal office hours Mondays to Fridays, 9am to 5pm.

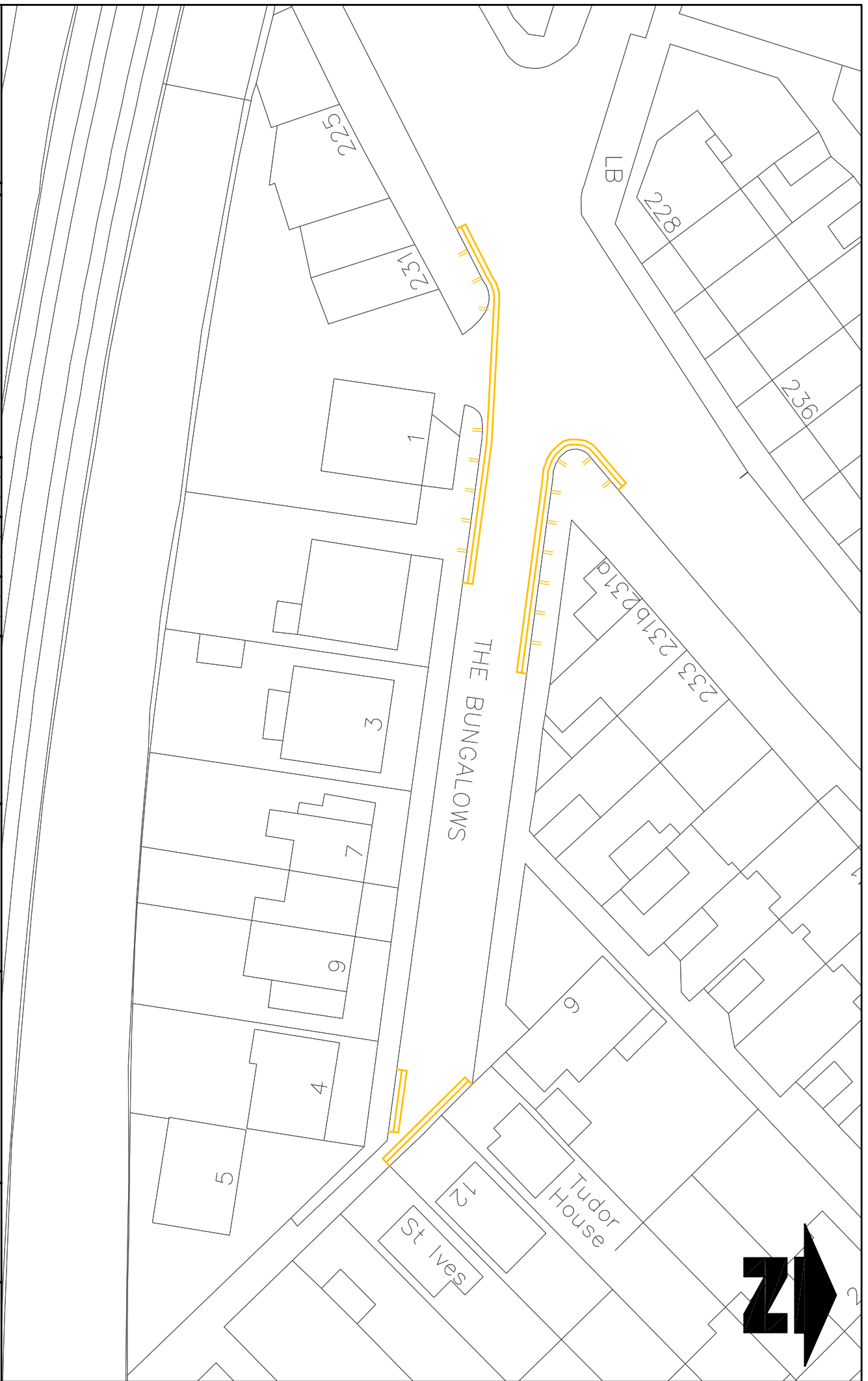
