## **Dear Resident / Business**

Following the Council's decision to introduce the VSW1 extn CPZ in Cottenham Drive, Cottenham Place and High Cedar Drive, I am writing to inform you that the works will start on 22 November 2018. and will be carried out by F M Conway Ltd on behalf of the Council.

## DATE AND TIME OF WORKS

The works including street cleansing are programmed to start the week commencing 22 November 2018 for a period of 2 days, weather permitting. Work will be carried out between 8am and 4.30pm. To allow the works to be carried out as quickly as possible, temporary parking restrictions will be introduced. "No Parking" cones and signs will be in place to indicate the areas where parking would be prohibited. By doing so, this will keep the road free of parked vehicles allowing a smooth transition of the works. Vehicles would be allowed back into the road to park once the lining work is complete or after the working day. Offending vehicles run the risk of receiving a fine and possible relocation. Notices and cones will be placed in your road 12 – 48hrs prior to work being undertaken.

The information on how to apply for your permit will follow shortly. For permit related issues please contact Parking Services on 020 8545 4661. The Council is conscious of the inconvenience and the disruption that these works may cause and will endeavour to keep the impact to a minimum. We apologise in advance for any inconvenience that may be caused by these works.

Proposed Controlled Parking Zone (CPZ) VSW1 Extn Cottenham Drive, Cottenham Place and High Cedar Drive

### Dear Resident / Business

This leaflet is to update you of the outcome of the statutory consultation that was carried out between 6 and 28 September 2018 on the proposals to extend VSW1 Controlled Parking Zone (CPZ) to include Cottenham Drive, Cottenham Place and High Cedar Drive operational Monday to Friday between 11am and 3pm.

The statutory consultation resulted in 14 representations. Two representations received from 'Homeowners Association' and 'Copse Hill Estate Residents Association' were submitted with attachments and petition. All representations received during the statutory consultation along with officer's recommendations were reported to the Cabinet Member for Regeneration, Housing and Transport in October 2018. After careful consideration the following have been agreed:

- To proceed with the making of the relevant Traffic Management Orders (TMO) and the extension of the VSW1 CPZ to include Cottenham Drive, Cottenham Place and High Cedar Drive, and operational Monday to Friday between 11am and 3pm.
- That the properties Nos. 1 23 and Nos. 52 -56 Cottenham Drive and Nos. 2 - 10 Cottenham Place (even numbers only), properties within the unadopted (private) sections of the estate, be eligible to purchase visitor parking permits only and not eligible for resident parking permits.

### What happens next

The final made TMO, which allows the restrictions to be implemented and administered, will be published in the London Gazette and the local newspaper shortly. Notices will also be placed



on lamp columns in the affected areas. It is anticipated that the CPZ will come into operation on 10 December 2018.
