### **Dear Resident / Business**

Following the Council's decision to introduce the CW4 and CW5 CPZs, I am writing to inform you of the implementation time table for December 2017. All the works will be carried out by F M Conway Ltd on behalf of the Council.

# DATE AND TIME OF WORKS

The works are programmed to start the week commencing 4 November 2017 for a period of 1 week, weather permitting. Work will be carried out between 8am and 4.30pm. To allow the works to be carried out as quickly as possible, temporary parking restrictions will be introduced. "No Parking" cones and signs will be in place to indicate the areas where parking would be prohibited. By doing so, this will keep the roads free of parked vehicles allowing a smooth transition of the works. Vehicles would be allowed back into the road to park once the lining work is complete or after the working day. Offending vehicles run the risk of receiving a fine and possible relocation. Residents will be allowed to park on the completed bays during the implementation work.

Notices and cones will be placed in your road 12 – 48hrs prior to work being undertaken.

SCHEDULE OF WORKS: The work schedule of when your road will be marked is shown below.

- · Christchurch Close 4 and 5 December.
- Colwood Gardens 6 and 7 December.

The information pack on how to apply for your permit will follow shortly. For permit related issues please phone Parking Services on 020 8545 4661. The Council is conscious of the inconvenience and the disruption that this work may cause and will endeavour to keep the impact to a minimum. We apologise in advance for any inconvenience that may be caused by these works.

# Proposed Controlled Parking Zone (CPZ) CW4 & CW5 - Christchurch Close & Colwood Gardens.

### **Dear Resident / Business**

This leaflet is to update the community of the outcome of the statutory consultation that was carried out between between 31 August and 22 September 2017, and to inform you of the Council's decision to introduce the proposed CW4 CPZ in Christchurch Close and CW5 CPZ in Colwood Gardens as shown in the plan overleaf.

The statutory consultation resulted in 3 representations, 1 representation from Christchurch Close and 2 from Colwood Gardens. All representations received during the statutory consultation along with officer's recommendations were reported to the Cabinet Member for Regeneration, Environment and Housing in October 2017. After careful consideration the following have been agreed:

- 1. To proceed with the making of the relevant Traffic Management Orders (TMO) and the implementation of the proposed:
  - (i) new CW4 CPZ to include Christchurch Close operational Monday to Friday 8.30am – 6.30pm and Saturday to Sunday 11am – 3pm.
  - ii) new CPZ CW5 to include Colwood Gardens operational Monday to Saturday 8.30am – 9pm (CW5).
- 2. To make an Exemption Order to allow footway parking in Christchurch Close to maximise the number of parking spaces

# What happens next

The final made TMO, which allows the restrictions to be implemented and administered, will be published in the London Gazette and the local newspaper shortly. Notices will also be placed on lamp columns in the affected areas. It is anticipated

that the CPZ will come into operation on **6 January 2018**. The report and the decision sheet can be viewed on the Council's website, www.merton.gov. uk/cpzcw
