### 1 PURPOSE OF REPORT AND EXECUTIVE SUMMARY

1.1. This report seeks approval of the Mitcham Cricket Green Conservation Area Appraisal and Management Plan 2013 (MCGCAAMP). The draft MCGCAAMP was originally produced in 2010 for public consultation. Following public consultation and subsequent amendments, the final appraisal and management plan is attached for approval.

### 2 DETAILS

- 2.1. Public consultation was carried out on the draft plan as set out in section 4 below. Following public consultation, a schedule of proposed changes was made available on the Council's website which identified the comments made and the Council's responses.
- 2.2. The draft document was amended and the final version is now attached as Appendix A for approval. Attached as Appendix B is the schedule of comments and the council's responses to them. Appendix C is the map showing the deletion of an area from the conservation area (Chatsworth

- Court and Lewis Court) as well as the addition of two areas to the conservation area (Glebe Court and part of Church Path and its surroundings).
- 2.3. On the 15<sup>th</sup> April 2013, the Cricket Green Charter was launched by the Mitcham Cricket Green Community and Heritage Group, outlining the Group's ambitions for the future of the Cricket Green. The Charter and Appraisal and Management Plan are mutually supportive in their aims to preserve the special interest of the Cricket Green area.

# 4 CONSULTATION UNDERTAKEN OR PROPOSED

- 4.1 Public consultation on the character assessment and management plan was carried out for a period of 6 weeks. Local residents were notified of the draft appraisal and management plan along with amenity groups, ward councillors and local businesses. In addition, an advertisement was placed in the local newspaper, giving notice of the draft documents and advising on the opportunity to comment on them.
- 4.3 A public meeting/workshop was held at the Vestry Hall to allow interested contributors to discuss any concerns before submitting their comments.
- 4.4 In addition to the above, the draft document was considered at a meeting of the former Conservation and Design Advisory Panel (now Heritage and Design Working Group).
- The full version of the draft was posted on the Council's web site and comments were invited.

### 5 TIMETABLE

5.1. Following Cabinet approval, the necessary notifications will be sent out and the final MCGCAAMP will be posted on the website

# 6 FINANCIAL, RESOURCE AND PROPERTY IMPLICATIONS

- 6.1 The document will be made available on the Council's website in an electronic version. A limited number of paper copies will be printed and the cost of this will be met from existing budgets.
- 6.2 Improvement identified within the Management Plan will be implemented when appropriate funding is identified.

- 7.1 Character assessments and management plans for conservation areas may be treated as material considerations in the determination of planning applications and appeals.
